- Raising of equity capital for an amount aggregating upto ₹7500 crore (including share premium, if any) in one or more tranches during FY 2024-25 through Qualified Institutions Placement (QIP)/Follow-on Public Offer (FPO) or any other permitted mode or a combination thereof in such manner and on such terms and conditions as may be deemed appropriate, in accordance with the applicable Acts/Regulations/Guidelines and subject to receipt of all requisite approvals and the shareholding of Govt. of India not falling below 52%, through *special resolution*.
- Appointment of Director on the Board of the Bank under Section 9(3)(a) of the Banking Companies (Acquisition and Transfer of Undertakings) Act, 1970, in accordance with the provisions of Regulation 17(1C) of the SEBI (LODR) Regulations, by way of *Ordinary Resolution*.

The Cut-off date for determining the eligibility of shareholders for e-voting in respect of the aforesaid Agenda Items shall be **Tuesday, 27th February, 2024**.
