### 1. Appointment as Scrutinizer

We were appointed as the Scrutinizer for the remote e-voting as well as the e-voting by Members during the 19<sup>th</sup> Annual General Meeting ("AGM") of Punjab National Bank (hereinafter referred to as the Bank) scheduled on Tuesday, 04<sup>th</sup> August, 2020 at 10:00 a.m. (IST) held through Video Conferencing ("VC") / Other Audio-Visual Means ("OAVM"). Our responsibility as a Scrutinizer was to ensure that the voting process was conducted in a fair and transparent manner and submit a Scrutinizer's report on the voting on the resolutions based on the reports generated from the electronic voting system.

### 2. Dispatch of Notice convening the AGM

Pursuant to General Circulars No. 14/2020, 17/2020 and 20/2020 dated 8<sup>th</sup> April, 2020, 13<sup>th</sup> April, 2020 and 5<sup>th</sup> May, 2020 respectively issued by the Ministry of Corporate Affairs, advertisement was published in Business Standard, (English newspaper) and Business Standard, Hindi edition (vernacular language newspaper), having electronic editions on 11<sup>th</sup> July, 2020 specifying the date and time of the AGM, availability of the notice on Bank's website and website of the Stock Exchanges, manner of registration of email ids by the members (both physical and demat) who are yet to register their email ids with the Bank, manner of voting through remote e-voting or through e-voting system at the AGM etc.

- 2.2 The Bank hosted the notice of AGM on its website, website of NSDL, (evoting Agency) and also intimated the same to BSE Limited and National Stock Exchange of India Limited on 12<sup>th</sup> July, 2020.
- 2.3 The Bank informed that on the basis of the Register of Shareholders and the list of Beneficial Owners made available by **Beetal Financial & Computer Services (P) Limited**, the Registrar and Share Transfer Agents ("RTA") of the Bank and the depositories viz., National Securities Depository Limited ("NSDL") and Central Depository Services (India) Limited ("CDSL") respectively, the Bank completed dispatch of Notice of AGM on **12**<sup>th</sup> **July**, **2020** by e-mail to all the Shareholders whose email ids were registered with the Bank / Depositories.

### 3 Cut-off date

Voting rights were reckoned as on **Tuesday**, **28**<sup>th</sup> **July**, **2020**, being the cut-off date for the purpose of deciding the entitlements of members for remote e-voting and e-voting during the AGM.

### 4 Remote e-voting process

### 4.1 Agency

The Bank appointed **National Securities Depository Limited ("NSDL")** as the agency for providing the platform for remote e-voting and e-voting during the AGM.

### 4.3 Remote e-voting period

Remote e-voting platform was open from 09:00 a.m. on Saturday, 01<sup>st</sup> August, 2020 till 05:00 p.m. on Monday, 03<sup>rd</sup> August, 2020 and members were required to cast their votes electronically conveying their assent or dissent in respect of the resolutions on the remote e-voting platform provided by NSDL.

### 5 Voting at the AGM

- As prescribed under Rule 20(4)(xiii) of the Companies (Management and Administration) Rules, 2014, for the purpose of ensuring that Shareholders who have cast their votes through remote e-voting do not vote again during the general meeting, the Scrutinizer shall have access after closure of period of remote e-voting and before the start of general meeting, to only such details relating to Shareholders who have cast their votes through remote e-voting, such as their names, DP ID & Client ID / folios, number of shares held but not the manner in which they have voted.
- 5.2 Accordingly, NSDL, the remote e-voting agency provided us with the names, DP ID & Client ID / folios and shareholding of the members who had cast their votes through remote e-voting.

### 6 Counting Process

- 6.1 On completion of e-voting during the AGM, we unblocked the results of the remote e-voting and e-voting by members at the AGM, on the NSDL e-voting platform and downloaded the results.
- No Shareholder of the Bank other than the Central Government holds more than 10% of total voting rights of all Shareholders of the Bank, accordingly, provisions of Section 3(2E) of Banking Companies (Acquisition and Transfer of Undertakings) Act, 1970 with respect to restriction of voting rights are not applicable.

### 7. Results

7.1 Consolidated results with respect to each item on the agenda as set out in the Notice of the AGM dated 09<sup>th</sup> July, 2020 is enclosed herewith.



7.2 Based on the aforesaid results, we report that **01 (One) Ordinary Resolution** as set out in Item No.1 and **02 (Two) Special Resolutions** as set out in Item No.2 and Item No.3 of the Notice of the AGM dated 09<sup>th</sup> July, 2020 have been **passed with the requisite majority**.
